CONFIDENTIALITY ORDER

This cause is before the Court on the JOINT MOTION TO DETERMINE TEMPORARY CONFIDENTIALITY OF TRIAL COURT RECORDS AND FOR IN CAMERA REVIEW OF PROPOSED CONFIDENTIAL DOCUMENTS. The Court having conducted an in camera review of the joint motion and court records delineated in the joint motion, it is,

ORDERED and ADJUDGED:

1. The Court finds that sufficient grounds have been demonstrated by the movants under Rule 2.420, Florida Rules of Judicial Administration, for temporary confidentiality of the enumerated court records.

2. The court records enumerated in the joint motion shall remain confidential and not available for public inspection for 120 days following entry of this Order. The confidential court records shall be placed in sealed envelope and marked on the outside as "Confidential Court Records Subject to the Attached Confidentiality Order." A conformed copy of this Order shall be affixed to the sealed envelope. The confidential court records shall become available for public inspection and filed in the Court file upon the expiration of 120 days from entry of this Order, or upon further order of this Court.


3. Only counsel for the movants shall be entitled to review the confidential court records while they remain confidential.

4. The progress docket and similar records maintained by the Clerk, both electronically and in writing relating to the joint motion, the confidential court records and the in camera discussion and inspection of the joint motion and confidential court records shall likewise remain confidential for 120 days following entry of this Order.

4. The Court finds that the degree, duration and manner of confidentiality provided for in this Order are no broader than necessary to protect the interests set forth in the joint motion and that no less restrictive means are available to protect those interests.

5. The Clerk of the Court shall publish this Order in accordance with Rule 2.420(e)(4), Florida Rules of judicial Administration.
